Backflow Preventer Checkup Program

JEA's Backflow Preventer Checkup program helps customers with JEA residential irrigation service connections comply with state environmental regulations designed to protect the quality of our drinking water.

If your backflow preventer is due for testing:

- JEA will schedule a certified backflow preventer tester to come to your home to test your device; you do not need to be at home and the inspector will not enter your home.*
- The \$35 fee for this testing will be added to your next JEA bill.
- The tester will report your test results to JEA and leave a copy of the findings at your home.
- If your backflow preventer passes the test, JEA will notify you that you are in compliance.
- If you prefer to hire your own contractor to conduct the testing, simply have your backflow preventer tested and submit the passing test report to JEA within 45 days. Upon receipt of the passing test results, JEA will notify you that your device is in compliance.

If your backflow preventer requires repairs:

- Select a vendor to make the necessary repairs.
- Once repairs are made, have your vendor retest the backflow preventer and submit the results to JEA.
- Upon receipt of a passing test result, JEA will confirm that your device is in compliance.

Lawn Irrigation Systems

Inground irrigation systems may utilize various sources of water. Each water source presents a different level of risk to the public water supply and has corresponding backflow preventer requirements

In-ground Irrigation Water Source	Backflow Preventer Required	Backflow Preventer Installation
Residential Water Service (potable water)	Double Check or Reduced Pressure*	Residential Water Service line or before irrigation system
Residential Irrigation Service (potable water)	Double Check or Reduced Pressure*	Residential Irrigation Service line
Residential Reclaimed Water Service	Double Check or Reduced Pressure*	Residential Water Service line
Surface Water (well, pond, other non-potable)	Reduced Pressure	Residential Water Service line

If your system requires repairs or replacement, contact one of <u>JEA's preferred backflow prevention</u> <u>vendors</u> for an estimate.

*DCVA is allowed if the irrigation service was installed prior to May, 2014. Irrigation services installed May, 2014 and after require RP backflow preventers.

Preferred Backflow Vendors

JEA's preferred vendor list is offered to customers for their convenience in choosing a vendor who meets our requirements to test, repair, replace and install backflow preventers. We do not recommend one vendor over another, and we strongly recommend you follow these steps when selecting a backflow preventer vendor:

- 1. Call several testers and ask what they charge for the annual test.
- 2. Ask them when they can come and do the test.
- 3. Ask the testers if they have a business license and insurance.
- 4. Ask the testers if they received their certification from a nationally recognized or state certification agency.
- 5. Ask the testers for a list of references or a list of satisfied customers.
- 6. Ask the tester if the company abides by and has signed a Code of Conduct with JEA.

If an assembly fails the test, it will need to be repaired or replaced and retested. Assemblies are designed to last many years, and they often can be repaired inexpensively. Sometimes all the assembly needs is a good cleaning. The repair on small assemblies normally does not take more than one extra hour of labor.

Non-residential backflow preventers are required to be tested annually. Residential backflow preventers are required to be tested once every two years. Whether or not you receive a courtesy reminder from JEA, you need to contract to have your backflow preventers tested before the due date. Be sure to have the test done early and don't wait until the end of the month. Many customers wait until the last minute and testers are very busy trying to meet the deadline.
